

Outreach


Figure 1. Map of the registered participants per country of residence

A total of 223 participants (83 women - 36%) from 52 countries registered to the webinars. Details are presented on the map (figure 1) and the chart (figure 2) below.

Figure 2. Number of registered participants per country of residence²




Polls

Figure 3. Summary of answers to the poll questions




Evaluation
