SUMMARY

The UNCTAD TRAINFORTRADE Port Management Week 2022 took place between 10–13 May in Las Palmas de Gran Canaria, Spain. In total ninety-three (93) representatives of forty-one (41) institutions from twenty-three (23) countries of the TRAINFORTRADE Port Management Programme attended the conference. The event was conducted in English, French and Spanish.

Delegates, including thirteen (13) CEOs of ports, took part in a series of port events to exchange on best practices and lessons learned in the three linguistic networks. During the global coordination meeting held on the third day, recommendations were adopted by the members of the TRAINFORTRADE Port Management Programme. The delegates praised UNCTAD for the relevance and impact of its TRAINFORTRADE capacity building programme in the various beneficiary port communities.

The delegates reaffirmed their annual financial support towards the activities of TRAINFORTRADE through its dedicated Trust Funds with contributions from the beneficiary members on the cost sharing principle and support from donors and port partners.

Pursuant to the UNCTAD 15 Bridgetown Covenant (From Inequality and Vulnerability to prosperity for All), the delegates requested that the UNCTAD TRAINFORTRADE programme be provided with the necessary internal and external resources to extend its capacity building activities towards the mandate, and covering in particular Trade Statistics and digital economy bridging the digital divide securing trade flows; building resilience to achieve sustainable development and mitigating climate change; and supporting economic empowerment of women.

The Port Management Week 2022 was hosted by the Port Authority of Las Palmas and the City of Las Palmas.

1. BACKGROUND

The UNCTAD TRAINFORTRADE Port Management Programme supports port communities in developing countries in delivering more efficient and competitive port management through its three language-based networks (English, French and Spanish) with port partners and members from Africa, Asia, Europe, Latin America and the Caribbean for the past 26 years. This high-level conference bringing together representatives from the three networks was the first Port Management Week since the COVID-19 pandemic started.

2. OBJECTIVES

The objectives of the Port Management Week were to build back better by:

- Engaging in high-level discussions on key thematics linked to the UN Sustainable Development Goals (SDGs) and port management. The topics included climate change, environment, digitalisation and cybersecurity.
- Participating in the global coordination meeting of the three TRAINFORTRADE language-based networks to exchange of information, best practices and recommendations.
- Assessing the latest trends of the Port Performance Scorecard and statistics of the networks.

3. CONDUCT OF THE CONFERENCE

The four-day conference took place on-site with simultaneous interpretation in English, French and Spanish.

The event was organized under daily thematic programmes, covering these main thematics: Opening and Port Visit; Port Performance; Global Coordination Meeting; and Port Thematics. The full agenda of the conference can be seen in Annex B and C..

All conference presentations have been shared with participants through TRAINFORTRADE's online course platform. Media coverage, photos, meeting recommendations and detailed results of the opinion questionnaire have been shared through the same platform.

Tuesday, 10 May - Opening and Port Visit

The event started with a 3-hour brainstorming private session on the Module 5C entitled: "Digital Port Management" from the TRAINFORTRADE renowned "Modern Port Management" course. Based on feedback from national deliveries of the module in beneficiary countries, a group of 12 conference guests were invited to examine, debate and re-design the existing course structure to take into consideration the latest trends in terms of digitalisation in the port sector.

Wednesday, 11 May – Port Performance

The second day was dedicated to port performance. After a presentation of the TRAINFORTRADE Port Performance Scorecard (PPS), four selected countries presented their PPS results. The programme continued with presentations of MarineTraffic and UNCTAD's Liner Shipping Connectivity Index, and was followed by a session on Key Performance Indicators.

Thursday, 12 May – Global Coordination Meeting – Port Networks

The focus of the third day was on discussing common thematics of the three networks relating to the implementation of the Port Management Programme in their respective port communities such as the port certificate recognition and the Port Management Series case studies. Six certified port professionals [presented their recognized case studies](#). These are dissertations of the Port Management Programme training process which have been featured in the last editions of the annual UNCTAD Port Management Series publications.

The day ended with drafting the nine recommendations of this Global Coordination Meeting. The port members are committed to implement these recommendations (see Section 6 below for the final recommendations).

Friday, 13 May – Port Thematics

During the last conference day, thirteen (13) CEOs of port members and partners participated in five panel discussions on current topics on port management, covering climate change & environment, supply chain resilience, digitalization, and the United Nations Sustainable Development Goals (SDGs). The details of the composition of each panel can be found in the detailed agenda in Annex C.

Panel 1: Climate Change & Environment: Decarbonization & Energy Transition

The three panellists, representing some of the major ports in Spain, elaborated on the necessary rapid adaptation of their respective port strategies over time to mitigate climate change and environmental concerns with the support of their port community, regions, and other ports from the European Union. Numerous projects are being implemented in relation to electricity substation, photovoltaic installations, Innovation hubs, air quality, support to local community, renewable energies, efficient management of energy networks or circular economy, new business opportunities in the logistics chain, the digitalisation of port processes, and port city integration.

Panel 2: Climate Change & Environment: Infrastructure Resilience

The three panellists, representing ports in Asia, Latin America and Europe, shared their experiences on the main effects that extreme events are having, regarding both their port infrastructure and operations. Seaports and inland ports provide different scenarios in this complicated environment. The discussions involved the importance of ports to become resilient partners of the supply chain, as well as the different tools, for example the Climate Vulnerability Assessment Plans or the Preparedness Plans, available to cope with the effects of climate change on Port Management. It was agreed that in the future port managers should promote the provision of smart and resilient port infrastructure as a key element for adapting to climate change risks.

Panel 3: Supply Chain Resilience & Diversification

The assurance and strength of supply chains, of which ports are fundamental components, was raised as a central theme in the panel. From the experience of the Covid-19 pandemic and its consequences, the panellists addressed the experiences in the face of the new ongoing threats: the increase in freight prices and the restrictions stemming from the war in Ukraine. One dramatic consequence of this conflict is the breakdown of essential food supplies for many African nations. Periods of famine are expected if the restrictions will continue. Regarding the possible relocation of manufacturers as a consequence of the increase in transport costs and

in delivery times, the panellists considered that the learning obtained during the pandemic could be a good basis for developing contingency plans for these eventualities.

Panel 4: Digitalization & Cybersecurity

The panellists, representing European and African ports, presented their experiences in digital transformation and cybersecurity, both from strategic and operational perspectives. There are many tools that have contributed to improving the efficiency of ports, such as single windows, port community systems, or smart energy management systems. In addition, new technological developments such as blockchain, artificial intelligence and big data analytics are fundamental in the process of digital transformation of the ports. Port Administrations have a key role in supporting port clusters in digital transformation processes. All the speakers highlighted the importance of training and the commitment of people in the process of building the smart ports of the future.

Panel 5: Ports and the United Nations Sustainable Development Goals

The main focus of the panel discussion was in relation to SDG 8 – Decent Work and Economic Growth and SDG 13 – Climate Action. The two panellists shared their experience with detailed insights into the strategies they engaged in to foster better relationships with employees and port communities living in and around the port estate. Much emphasis was placed on the role of ports in generating employment and educational opportunities for local people and fostering good relationships with all port stakeholders. In addition, the speakers noted how ports through their development plans can help to ensure that due care and attention is paid to improving the physical environment within the port and in their neighbourhoods. It was agreed that the SDGs provide a blueprint for ports to report on progress in relation to climate change and sustainability.

4. PARTICIPANTS

Representatives of TRAINFORTRADE Port Management Programme port members from Africa, Asia, Europe, Latin America and the Caribbean were invited to participate in the Port Management Week. The complete list of participants can be found in Annex A.

Due to the physical limitations of the conference, the following representatives were prioritised:

- CEOs of the port authorities
- Port Management Programme Focal Points
- Port Performance Scorecard (statistics) Contact Points

In total **93 participants from 41 institutions in 23 countries** attended the conference:

- 10 participants from the English-speaking network;
- 36 participants from the French-speaking network;
- 25 participants from the Spanish-speaking network;
- 22 participants from other institutions.





5. FEEDBACK

The overall satisfaction rate for the conference was **over 93%**. Participants indicated for example the following observations:

- “The conference tackled relevant and timely themes that ports around the globe, whether big or small, should address.”
- “Participation of many CEOs and their presentation contributed a lot to strengthen our UNCTAD Port Community.”
- “The knowledge shared here will contribute greatly to my planning of work in the coming months and beyond.”
- “This conference increased my awareness and helped advance my advocacy on those issues that matter strongly to improving port management and in delivering better services to port customers.”

6. IMPACT

During the global coordination meeting the following recommendations were adopted by the members of the TRAINFORTRADE Port Management Programme.

Recommendation 1:

The delegates praised the UNCTAD TRAINFORTRADE for the relevance and recognized the impact of its capacity building programme in the various beneficiary port communities. The existing global context highlighted the key role ports play in securing international trade and vital merchandises around the world and the absolute necessity to maintain the highest degree of efficiency in the whole chain of transport.

Recommendation 2:

The Building Port Resilience Against Pandemics (BPR) component is of crucial importance to the port members and also to all port communities around the world. Delegates praised UNCTAD for this important initiative and invite TRAINFORTRADE to pursue the delivery of the BPR component to all port communities in the three languages looking for more financial support with donors.

Recommendation 3:

All members of the Port Management Programme are invited to contribute to the Port Performance Scorecard on a yearly basis using the upgraded pps.unctad.org platform, and to extend the number of port entities from port communities with very large number of ports (eg: Indonesia, Philippines, Argentina, etc.). Top management of the reporting port entities are invited to support the data collection process for PPS by nominating dedicated person(s) to complete the surveys directly on the platform. Follow-up workshops will be organized to promote the development of the platform.

An extension of the PPS will also be open to non-members on a case-by-case basis with a win-win approach to increase the relevance of data points collected and refinement of the regional benchmarks. Port entities are also invited to authorize on a voluntary basis their PPS data to be visible like the port partners and some members already do to share good practices and allow more comparisons and cross analysis.

Recommendation 4:

The delegates praised the South-South cooperation model developed by TRAINFORTRADE across all its linguistic networks with the full participation of beneficiary ports, port partners and other national actors from the various port communities.

Recommendation 5:

Under the impetus of the TRAINFORTRADE programme, port leaders will support the development of new skills and equality of opportunities in the port community in line with the challenges of sustainable ports and linkages to the UN SDGs.

Recommendation 6:

The delegates agreed to promote former participants of the Port Management Programme as instructors for the national deliveries of the Modern Port Management course to bridge knowledge internally and support career development.

Recommendation 7:

Port members agreed to support the process of dissertations by following up on recommendations and identifying the relevant UN SDGs and its impact on the port community across cycles (national deliveries).

Recommendation 8:

The delegates reaffirmed their annual financial support towards the activities of TRAINFORTRADE through its dedicated Trust Funds (T7BR, T4AB, T5BS and T6AR) with contributions from the beneficiary members on the cost sharing principle and support from donors and port partners. Potential new donors and port partners could be invited to support the joint programme activities.

Recommendation 9:

Pursuant to the UNCTAD 15 Bridgetown Covenant (From Inequality and Vulnerability to prosperity for All), the delegates requested that the UNCTAD TRAINFORTRADE programme be provided with the necessary internal and external resources to extend its capacity building activities towards the mandate covering in particular; Trade Statistics and digital economy bridging the digital divide, securing trade flows and building resilience to achieve sustainable development and mitigating climate change, and supporting economic empowerment of women.
